Meeting Number 21.371

21.371.1 Apologies for Absence

Councillors Bohm (DB), Davis (SD), Stafford Allen (RSA), Donne (HD), Mullane (NM) and Whitfield (RW) were all present.

There were no members of the public present.

21.371.2 Declarations of Interest

There were no declarations of interest presented in relation to this meeting.

21.371.3 To Discuss Parish Council response to Oxfordshire Plan 2050 consultation

DB highlighted there are currently 3 development plans affecting Oxfordshire with consultations either underway or about to commence:

- Cherwell Local Plan Review
- Oxfordshire 2050 Plan
- Oxford-Cambridge Arc

Oxfordshire 2050 Plan information slides provided by a Town & Parish briefing meeting, attended by DB, were presented.

CPRE also sent a paper to the Council highlighting potential responses to key themes in the Oxfordshire 2050 Plan - 'Oxfordshire Plan 2050 (Regulation 18 Part 2) consultation – CPRE Oxfordshire's '10 Minute Response' Guide'

DB asked the council how they felt about framing the discussion and response to the Oxfordshire 2050 Plan around the view points of CPRE.

Councillors agreed to base the Parish Council response to the Oxfordshire 2050 Plan consultation on the comments provided by CPRE. Modifications were highlighted to take account of our Parish specifics including the use of MoD land with regards to the Weston on the Green airfield and in relation to urban housing vs rural housing patterns and to encourage bio-diversity corridors.

The consultation on the Oxfordshire 2050 Plan closes on 8 October 2021.

DB will circulate a draft response to the Oxfordshire 2050 Plan consultation and it will be discussed further at 6th October 2021 Parish Council meeting.
