This website is run by 123Connect Ltd. The Parish Council want as many people as possible to be able to use this website, for example, that means you should be able to:

- change colours, contrast levels and fonts

PDFs and other documents

Many of our older PDFs and Word documents do not meet accessibility standards - for example, they may not be structured so they're accessible to a screen reader. This does not meet WCAG 2.1 success criterion 4.1.2 (name, role, value).

Some of our PDFs and Word documents provide useful information on the operations of the Parish Council. By the end of December 2020, we plan to either fix these or replace them with accessible HTML pages.

The accessibility regulations [do not require us to fix PDFs or other documents published before 23 September 2018](#) if they're not essential to providing our services. For example, we do not plan to fix agenda and minute documents from before this date (unless a request is received for a particular document).

Any new PDFs or Word documents we publish will meet accessibility standards.

Navigation around Agendas & Minutes' page

Some of the text within this page may be difficult to currently navigate due to the same words being used as links e.g. agenda, minutes.

This is linked to WCAG 2.1 success criterion 2.4.6 (headings and labels).

The page will be re-worked by the end of December 2020 in order to remove the repetitive wording and improve the navigation of the 'Agendas & Minutes' page.

How we tested this website

This website was last tested on 9th September 2020. The test was carried out by 123Connect.

We tested and amended each page on our main website platform, available at: www.westononthegreen-pc.gov.uk

Tests were carried out by an automated process: WAVE, AXE and backed up by Microsoft Accessibility Insight.
