### 5. Councillor Vacancy Notice

Cherwell District Council provided a vacancy notice on 9<sup>th</sup> October 2023 following notification of the resignation of Councillor Rosser.

In accordance with the Local Elections Rules an election to fill the vacancy shall be held if, within 14 days after the date of this notice (i.e. no later than 27 October 2023), a request for an election to fill the said vacancy is made in writing to Cherwell District Council by ten electors. In the event that no such request is received by 27 October 2023 the vacancy will be filled by co-option.

### 6. Footpath 27 (Westlands Avenue – North Lane) Modification Order Notice

Oxfordshire County Council has now produced a formal Modification Order for Footpath No. 27, which runs between Westlands Avenue and North Lane. This Order is publicised and relates to the incorrect position of Footpath 27 on the definitive map, as has been previously highlighted to the Council.

Any representation or objection relating to the order must be sent in writing to the Principal Officer, Countryside Records, Oxfordshire County Council, County Hall, Oxford OX1 1ND, or <a href="mailto:countrysiderecords@oxfordshire.gov.uk">countrysiderecords@oxfordshire.gov.uk</a> not later than 8 December 2023 and applicants are requested to state the grounds on which it is made. If no representations or objections are duly made to the order, or if

any so made are withdrawn, Oxfordshire County Council, instead of submitting the order to the Secretary of State may itself confirm the order.
